1. Components/materials used in the equipment shall meet the component policy Spec no: PP-E-2061. Copy of above specifications is enclosed.
2. Vendor need to provide the QA plan and Acceptance Test Procedure ATP along with quotation including spares, Tests on Prototype and tests on bulk quantity. Manufacturer shall submit a detailed test procedure for approval by ECIL/NPCIL to test all the requirements given in this specification. The manufacturer shall submit a detailed Quality Assurance Plan (QAP) based on the above including additional tests if any, required to meet the intent of this specification for approval before commencement of fabrication. The supplier shall submit 3 sets of all the detailed fabrication drawings and test procedure for approval by ECIL/NPCIL before commencement of fabrication.
3. The blank PCB's used in the equipment shall be manufactured from LCSO/NPCIL approved sources.
4. The supplier should provide along with the quotation copies of test reports and test results of environmental tests if already carried out by them on models of equipments offered against this enquiry.
5. The supplier should provide along with the quotation test reports of EMI / EMC tests if carried out on models of equipments offered by them.
6. Installation and commissioning of the equipment at KAPP 3&4 site and RAPP 7&8 is in the scope of supplier. ECIL will extend logistics support during Installation.
7. IHD (Instrument History Docket) shall be submitted with the equipment.
8. Required training has to be provided to NPCIL/ECIL engineers on operation/ maintenance of the Equipment.
9. The equipment shall be guaranteed against defects arising due to design faults, material, Workmanship, poor packing and damages during transportation, handling, storage etc. and for trouble free operation for a period of one year from the date of satisfactory commissioning of the unit site and final acceptance by NPCIL.
10. The supplier shall also carryout repair/rectification of failed component free of cost at site during the warranty period with required spares and components
11. The supply should also provide an undertaking for repair of equipment at least for a period of **5 years**, supply of components for a period of **10 years** after the warranty period.
12. The Supplier's liability for latent defects warranty for the plant and equipments including spares shall be a for a period of five (5) years from the end of warranty period

16. The inspection shall be carried out at supplier works as per the mutually agreed QA plan to meet the customer hold points of the QA plan.. Tests for which facilities are not available with the supplier, the same shall be arranged by the supplier at reputed test laboratories approved by NPCIL
17. Supplier should have supplied the equipment in sufficient quantities for any of the nuclear power plants and shall have a good record of performance. The supplier shall submit documentary evidence of having supplied the equipment.
18. The inspection shall be carried out at supplier works as per the accepted QA plan to meet the customer hold point of QA plan. Tests for which facilities are not available with the supplier, the same shall be arranged by the supplier at reputed test laboratories approved by NPCIL
19. Supplier should have supplied the equipment in sufficient quantities for any of the nuclear power plants and shall have a good record of performance. The supplier shall submit documentary evidence of having supplied the equipment.
