**I. GENERAL INSTRUCTIONS:**

1. Bids shall reach DGM, Purchase, RID, ECIL on or before the due date and time specified. Bids received after due date will be rejected summarily. Request for extension of due date will not be considered. ECIL will not be responsible for late delivery due to wrong or improper address. However, ECIL, at its sole discretion, may extend due date and will notify through ECIL web site: www.ecil.co.in or through e-mail individually.
2. Bidders shall submit their Bids in Two Parts (**Part 1. Techno commercial Bid** **2. Price Bid**). Bids not submitted as two-part will be rejected summarily. Techno-commercial Bid with price indications will not be considered.
3. Techno Commercial and Price Bids shall be submitted simultaneously in **two** separate covers, sealed and superscribed as "**TECHNO-COMMERCIAL BID**" and "**PRICE BID**" on respective covers with Tender Notice No., Date and Due Date. These **two** sealed covers shall be kept in a separate single cover and sealed again, superscribing with Tender Notice No., Date, Due Date, bidders address with their Email-Id and Contact Nos.
4. Indian origin bidders shall submit their quotes in Hard Copies only. Bids received through Email/Fax from Indian origin Bidders will be rejected summarily.
5. Bidders shall comment in their **TECHNO COMMERCIAL BID** that they understood and accepted / deviated about Each and every term & condition specified in (A) General Information (B) Commercial Information & (C) Technical Information of **Point III** hereunder without fail. 
**III. TECHNO COMMERCIAL BID SHALL CONTAIN:****A. General Information**

1. If the Bidder is an Authorized Distributor to OEM, the Bidder shall invariably submit the Authorization letter of OEM
2. If the Bidder is not a registered vendor with ECIL, they have to submit (a) Copies of Balance Sheet, P&L Account and IT Returns for the past 3 years (b) Details of Capability Certificate if any Viz., ISO 9000 etc. (c) Details of similar orders executed during past 3 years shall be submitted.

**B. Commercial Information:**



3. **Delivery:** Material shall be supplied within 2 months. **Delivery is essence of the Contract.**
4. **Terms of Price:** Bidders shall preferably quote for free delivery at our stores.
5. **Taxes & Duties:** All taxes and Duties shall be mentioned in your tender.
6. **Warranty:** Warranty 24 months from the date of supply. Please explain modus operandi for warranty support. The replacements of the defective items / rejected items during our Inward Inspections shall be done within two weeks of intimation from ECIL. 8. **Risk Purchase Clause:** The standard risk purchase clause is applicable to this requirement. The clause read as "In the event of failure to comply with the purchase order terms & conditions, ECIL has right to cancel the order and proceed with an alternate source. In such case, you shall have to bear the extra cost incurred by us which will be recovered from your available credit". Please convey your acceptance in your quote.
9. **Arbitration:** Any dispute arising out of contract/purchase order or interpretation of any clause or terms & Conditions here of shall be settled through conciliation by both the purchaser and the supplier under the specific provisions of arbitration & conciliation act 1996.
