9 <b>Performance Bank Guarantee (PBG)- Cum-Security Deposit:</b> The Contractor should furnish performance bank guarantee @ 5% of the total contract value valid for entire duration of contract period including the extended period of contract considered, if any, issued by a scheduled bank, within 15 days of award of contract towards security deposit and performance of the contract. The PBG shall be extended from time to time, as demanded by ECIL, to cover the intended obligation. PBG shall be submitted in the format as per Annexure – I.	<b>Performance Bank Guarantee (PBG)- Cum-Security Deposit:</b> <u>The successful contractor, initially, should furnish performance bank guarantee @ 5% of one year contract value of Rs.3.00 Crores i.e. Rs.15,00,000/- and should be extended prior to expiry for another year including the extended period of contract considered, if any, issued by a nationalised bank, within 15 days of award of contract towards security deposit and performance of the contract. The PBG shall be extended from time to time as demanded by ECIL to cover the intended obligation. PBG shall be submitted in the format as per Annexure – I of R.F.Q.</u>
