#### 5. PRE QUALIFICATION CRITERIA:

To participate in this EOI, bidders have to satisfy the following conditions and submit the listed documents, completed in all respects in support of the prequalification.

(a) **ECIL** invites responses to this request from Original Equipment Manufacturers (OEM / AUTHORISED DISTRIBUTORS).

(b) **For Indian Companies:** Certified document from Company Secretary (CS) or Chartered Accountant (CA) shall be submitted by the OEM / AUTHORISED DISTRIBUTORS confirming the following clauses:-

- Certificate of Incorporation from Registrar of Companies.
- Articles and Memorandum of Association.
- Annual Report for the last three financial years.
- OEM / AUTHORISED DISTRIBUTORS should be profit making company and Documentary evidence for same to be provided.
- The OEM / AUTHORISED DISTRIBUTORS should provide copy of Permanent Account Number.
- OEM / AUTHORISED DISTRIBUTORS should have valid excise, permanent sales tax and service tax registration number, if applicable.
- The OEM / AUTHORISED DISTRIBUTORS shall not be a black listed company or involved in any corrupt/ fraudulent practices by Central/ State Government ministries or PSUs. Company Secretary certified document should be submitted in this regard.
- The OEM / AUTHORISED DISTRIBUTORS shall have ISO/BVQI/equivalent relevant certificates in respect of OEM / AUTHORISED DISTRIBUTORS.

- ECIL shall have the right to select solution from multiple OEM / AUTHORISED DISTRIBUTORS.
